FOR IMMEDIATE RELEASE -- November 18, 2011 – Four Seasons Produce, Inc., of Ephrata, PA, announces a Precautionary Notice on Farm Wey Label Cantaloupes because there is the potential of the cantaloupes to be contaminated with Salmonella. The Farm Wey Cantaloupes were grown and packed in Georgia. Four Seasons Produce distributed Farm Wey Cantaloupes between the dates of October 21, 2011 and November 9, 2011.

No illnesses have been reported to date. This notification is being issued out of an abundance of caution based on an isolated instance in which a product sample had a positive result for Salmonella in a random sample test conducted by the U.S. Food and Drug Administration.

Healthy people infected with Salmonella should monitor themselves for some or all of the following symptoms: nausea, vomiting, diarrhea or bloody diarrhea, abdominal cramping and fever. Rarely, Salmonella can result in more serious ailments including arterial infections, endocarditis, arthritis, muscle pain, eye irritation and urinary tract symptoms.

Consumers exhibiting these signs after having contact with this product should contact their healthcare providers.
